Electricity Market Reform

- Activity Type: Study Visit
- Beneficiary: State Electricity Regulatory Commission (SERC)
- Proposed date: End June / early July or September
- Points of interest: Proposed visit to Brussels and one additional Member State



Technical standards for integration of Renewable Energy to the grid

- Activity Type: Seminar
- Beneficiary: SERC
- Proposed date: mid-June
- Points of interest: activity actually envisaged as an expert study group with findings delivered at a seminar



Pricing and market regulation

- Activity Type: Internship(s)
- Beneficiary: SERC
- Proposed date: September – November (inc.)
- Points of interest: EU-side will propose most suitable destinations for interns (in consultation with MS)



Access to the electricity markets in China & EU

- Activity Type: Workshop
- Beneficiary: SERC
- Proposed date: November
- Points of interest: Should gain impetus to contribute to outcomes of EU-China high level energy meeting



Energy Efficiency & Demand Side Management

- Activity Type: Workshop
- Beneficiary: SERC
- Proposed date: October
- Points of interest: Questionnaire to be drafted and circulated to identify potential pilot cities, with the workshop to be held in chosen cit(y/ies)



Energy efficiency in Buildings

- Activity Type: Study visit
- Beneficiary: Ministry of Housing & Urban/Rural Development (MoHURD)
- Proposed date: 28 May – 02 June
- Points of interest: Visit focused around concerted action meeting in Athens. Builds on seminar held in Beijing at the end of March.



Executive Training for newly-appointed officials after government reshuffle

- Activity Type: Workshop(s)
- Beneficiary: NDRC, MoHURD, MOFCOM, NEA, MOST, SERC, SGCC
- Proposed date: March 2013
- Points of interest: This activity represents a new model for EUCTPII and will be designed with close input from beneficiaries to ensure feasibility and impact



EU-China Smart City Expert Group

- Activity Type: Workshops
- Beneficiary: Ministry of Industry & Information Technology (MIIT)
- Proposed date: 3 workshops – 2nd half 2012
- Points of interest: This activity is aimed to establish an EU-China expert group and meetings will be aligned with other activities to maximise impact

EU-China Smart City Cooperation

- Activity Type: Study visit
- Beneficiary: MIIT
- Proposed date: November, before or after dialogue meeting
- Points of Interest: Representatives of Chinese green smart city pilot and officials will travel to European pilot cities – a reciprocal meeting in the Chinese pilot for EU representatives will also be held.

Development of policies to increase the uptake of sustainable technologies

- Activity Type: Workshop
- Beneficiary: MoHURD
- Proposed date: TBC
- Points of interest: There is a mutual interest in exploring ways to facilitate the access to specific technologies. This activity will be designed in collaboration with EUCCC.



Low Carbon Economy and ETS

- Activity Type: Seminars
- Beneficiary: NDRC
- Proposed date: Twice in second half of 2012
- Points of interest: These seminars are being designed and planned in collaboration with the ongoing ETS project



Launch of ETS Technical Guidebook

- Activity Type: Seminar
- Beneficiary: NDRC
- Proposed date: Guidebook will be completed for launch in September
- Points of interest: Guidebook is designed to present the European method of establishing ETS system in the Chinese context.



Monitoring, Reporting and Verification of Green House Gases and compliance on ETS

- Activity Type: Study visit
- Beneficiary: NDRC
- Proposed date: Late August / Early September
- Points of interest: Concrete proposal currently under discussion with NDRC
